

1. Students registration / attendance as per the rules enumerated.
2. The said School shall not open more sections without prior permission from the Government.
3. As per the provisions of Karnataka Education rules (Act) Rule No.3 Government Order No.ED/131/VVD/98/Bangalore Dated: 04-11-99, the Security Deposit is to be maintained in the Joint names in Nationalised Bank.
4. As per Karnataka Education Act 1993 the required furniture, Educational Library, Play - Ground, School Building etc, and essential facilities to be provided within six months.
5. Every year there should be medical checkup to the School Children's.
6. Every year the accounts of the organisation must be Audited and be produced to the Accounts Verification Officer (without fail)
7. Every year the recognition is to be renewed within 2 months from the date of opening of the School.
8. Every year School Audit should be conducted.
9. The fees must be collected only to the Extent prescribed by the Department and donations are prohibited.
10. Text books prescribed by the Department must be taught.
11. Schedule Caste/Schedule Tribes in Primary School 50% Schedule Caste/Schedule Tribes registration and presence.
12. Every year the Organisation should get the registration (Recognition) renewed.

If the above conditions are not implemented (complied) within one year under the Educational Rules, rule No.39 without giving prior notice to the management will be taken steps to with draw the recognition.
